I expressly assume all risks and hazards incidental to such participation, and I do hereby waive, release, absolve, indemnify and agree to hold harmless the FBA Academy/Fryer Basketball Academy, its staff, suppliers, sponsors, participants for any claim arising out of injury or illness to the said camper, regardless of the cause.

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

FBA Academy/Fryer Basketball Academy (FBA) has put in place preventative measures to reduce the spread of COVID-19; however, FBA cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending FBA could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending FBA and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at FBA or participation in FBA programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless FBA Academy/Fryer Basketball Academy, its staff, suppliers, sponsors, participants of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the

actions, omissions, or negligence of FBA, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any FBA program.
